Jourdanton Residents up to 50 swimmers: \$200.00 for two hours; \$250.00 for three hours.

- Additional swimmers over 50 will be charged \$50 for each group of up to 25 additional swimmers- a minimum of three days advanced notification required to add additional swimmers. Only swimmers with a pre-paid wristband can enter the pool.
- If you exceed your allotted rental time \$50 will be charged for every 10 minutes the guests are in the Aquatic Center.
- 25% discount for City of Jourdanton employees
- 25% discount for rental of Aquatic Center Pavilion only - no pool rental- no swimmers.

Non- Residents up to 50 swimmers: \$225.00 for two hours; \$275.00 for three hours.

- Additional swimmers over 50 will be charged \$60 for each group of up to 25 additional swimmers- a minimum of three days advanced notification required to add additional swimmers. Only swimmers with a pre-paid wristband can enter the pool.
- If you exceed your allotted rental time \$60 will be charged for every 10 minutes the guests are in the Aquatic Center.

Deposits will be refunded (5-10 business days) after your event provided there is no last-minute cancellation, trash, or damage, etc. to the facility. The city will retain the rental deposit if the cancellation is not made at least three working days prior to the scheduled event at cityhall@jourdantontexas.org .

Event setup can begin 30 minutes prior to the event at the pavilion- no swimmers or guests at that time. Guests will be allowed to enter the facility at the start of the rental event time slot. Approved food, decorations, tables, and chairs can be brought into the facility. No loose balloons. Balloons must be secured on the fence. No grilling in the Center or parking lot.

The City Manager reserves the right to close the Aquatic Center in the event of inclement weather event i.e., lightning within 10 miles- until the weather event has passed for 30 minutes or in the event of other safety - related considerations. No refunds- sorry

NO ALCOHOL, charcoal / gas grills, or glass containers are allowed in any part of the Sports Complex to include the Aquatic Facility.

- **Reservation requests are not considered confirmed until the city has received a signed copy of this Reservation Request Form and full payment to include the deposit. No phone reservations accepted.** Payment checks will be made payable to the City of Jourdanton
- It shall be the responsibility of the person signing the reservation application to comply with, and to enforce, all rental event rules and regulations. Violation of rules and regulations are grounds for forfeiture of deposit or cancellation of the event by the City Manager- with no refund.
- It is the responsibility of the individual signing the reservation form to set up and clean up the facility unless other arrangements have been made.
